Restoration Instruction

A Noble who has been suspended from any other Shrine Temple may restore his Shrine membership directly into Medinah Temple if he meets the following criteria.

1. He is a resident of Illinois, living in any county except Saint Clair, Sangamon, Peoria, or Winnebago.
2. He is current as a Master Mason in a blue lodge recognized by the Conference of Grand Master.

Former members of Medinah can restore membership regardless of their residence. They must, however, show evidence of good standing as a Master Mason.

Procedure

1. Complete the Restoration Petition.
 - a. If you do not know members to sign the sponsor lines, leave them blank.
2. Attach a copy of your current Blue Lodge dues card.
